## Notification related to Delegate -Election dt. 05.02.2024

Other important issues related to Election of Delegates-2024.

- The Term of Delegates will be Five years from the date of Election of Delegates-2024. However, in case of retirement from the service / death / resignation etc. (in whatsoever if he / she will not be in service) the elected Candidate's Delegateship / Directorship (whatever it may be) will be ceased on the date of Superannuation/ death / resignation as the case may be.
- Every eligible member for cast his / her vote shall produce his / her Office Identity Card (in original)duly issued by appropriate Railway Authority before the Election Officer / Addl. Election Officer. The Election Officer shall provide all the eligible members the opportunity to cast the vote if he (election Officer) satisfies the identification of the member through the document/s produced by the member that he / she is a voter of that Booth.
- Since in the B.O.D, the Seats shall be reserved in respect of SC /ST (One Seat) and Women (two Seats) as per sub-section (3) of Section 41 of the M.S.C.S Act, 2002, as amended on 03-08-2023 / 04-08-2023 the Reservation in respect of SC / ST and Women, is applicable in the Delegate Election also. As on the basis of the available Data with the Bank and the decision of the Bank Authority (B.O.D), Reservation towards one seat for SC / ST will be considered where the number of Delegates to be Elected will be for 5 (Five) and above in a constituency. In case of Reservation for Women Candidates, where the number of female members in a constituency is fifty (50) and above, one (01) seat would be reserved for Women.
  - Where the Election will be made for three categories of Candidates i.e for General / SC-ST / Women, there will be three different coloured of Nomination Papers, one for General Candidates, one for SC /ST Candidates and another for Women Candidates.



- In case of candidate willing to contest for the Reserved Seats, the Candidate shall fill in the designated Nomination paper mentioning for the particular reserved seat for which he / she is filling the nomination.
- No member shall file the Nomination for the General Seats and Reserved Seats simultaneously i.e Nomination can be filed either under Reserved Seats (SC /ST and Women) OR under Non-Reserved / General Seats.
- To identify the category of the Candidates for which the Nomination Paper is filed, Nomination Papers would be of three colours, viz.
  - White for General Candidates
  - Yellow for SC /ST Candidates
  - Pink for Women Candidates.
- Due to reservation of Seats (General / SC ST & Women) the Ballot Papers of each category will be different viz.
  - White for General Candidates
  - Yellow for SC /ST Candidates
  - Pink for Women Candidates.
- Due to reservation of Seats (General / SC ST & Women) the Ballot Boxes in each constituency will also be three marked separately as :-

For General Candidates / For SC /ST Candidates / For Women Candidates.

• Election Officer / Addl. Election Officer will positively provide three Ballot-Papers to each Voter. The Voter will Cast the Candidates with ball point pen kept in the voting compartment as per their choice and insert in the respective Boxes. All the Voters will cast their votes in favour of the Candidates of all Categories of Candidates (General / SC ST & Women as per their Choice. This is applicable in the constituency where the Candidates for three categories have submitted the Nominations Papers separately considering the Reserved Seats as stated.

However, mere wrong dropping of the Ballot Papers to the other Ballot Boxes would not be treated as Cancelled, if otherwise found correct.



- The Hearing of objection / Correction etc. would be heard by the Election Officer of each and every constituency. On the basis of the requisition made by the Election Officer / Addl. Election Officer, the Bank authority shall depute its Officials from the concerned Branches /H.O to assist the Election Officer / Addl. Election Officer for the purpose of the hearing of objection / correction etc. The decision of the Election Officer / Addl. Election Officer in this regard will be final and binding upon all.
- The Final Voter List will be prepared after obtaining the hearing of the objections / Correction etc. By the concerned Election Officer. for the preparation and publication of the final voter list, the dissension of the election officer shall be final.
