Notification related to Delegate –Election dt. 07.02.2024

In continuation with our earlier Notice dt.30.01.2024 and Corrigendum thereon dt.05.02.2024, it is stated further that as per prevailing norms the Bank authority sent the letters to the Eastern Railway and East Central Railway Authorities informing about the ensuing election of Delegates which is scheduled to be held on 27.02.2024 in compliance of the Order issued dt. 19.01.2024 by the Asstt. Registrar (Co-operation)-Office of Co-operation Election Authority, Ministry of Co-operation for conducting B.O.D Election on 4th. April, 2024 and requesting them to provide the Officials of Railways to conduct the Election as the Election Officers at the different Offices under different Divisions of the Railways (E. Railway and E.C. Railway). The respected E.C. Rly. Authority has kindly consented vide their letter under reference no.ERECB/ELED/DLGT/CPO/ECR/2024 dt.07.02.2024 with our request and issued necessary instruction to the Offices concerned to hold Delegate Election on 27.02.2024. But respected Authority of the Eastern Railway vide their letter under reference E.257/11/0/1/Co-Op/ Pt. XX dt. 08.02.2024 informed the Bank Authority regarding their inability provide infrastructure, manpower etc. to hold Delegate election on the said date. Further, they request to hold the Election in the first week of April, 2024.

Since the Election of Delegates of the Bank cannot be held without the kind co-operation of both of the Railway Administrations, the entire matter has already been communicated to the Co-operation Election Authority, Ministry of Co-operation, Govt. of India, New Delhi for their intervention and necessary order on the above stated matter.

Since B.O.D of the Bank did not get any order / advice from the Competent Authority the entire election process as notified as stated above is being kept in abeyance.

Further notification/ instruction shall be given as and when necessary after having Direction / Advice / Order from the Competent Authority.

This notification is issued in concurrence with the direction of B.O.D of the Bank and for general awareness and information to the all members of The Eastern Railway Employees' Co-operative Bank Ltd.
