## ADVISORY

Further to our earlier Notifications / Instructions issued on different dates regarding ensuing Delegate Election-2024 of the Bank, scheduled to be held on 18-07-2024, a brief note has been prepared for better understanding is given below:-

- 1. Each member shall cast his /her vote in favour of the Delegate/s of his / her choice. His /her vote should not exceed the no. of Delegate to be elected. If exceeds the Ballot Paper will be treated as rejected.
- 2. Proxy voting is not allowed at all.
- 3. Voting shall be done by secret ballot, provided by the concerned Election Officer / Addl. Election Officer and /or his authorized person, duly signed & stamped on the reverse side of the each and every Ballot Paper.
- 4. The Voter will inscribe the 'X' mark or '✓' mark for casting of their vote by using Blue Inked Ballpoint Pen only. The pens shall be supplied by the E.O. / Addl. E.O. / his authorized person.
- 5. The Voters will cast the Candidates as per their choice and insert the Ballot Paper in the respective Box/es.
- 6. Blank Ballot Papers / Partial printed Ballot Papers having serial no. if found in the Ballot Paper Book/s, shall be treated as cancelled by the concerned Election Officer / Addl. Election Officer. And the said Ballot Paper/s shall be kept separately putting a cross line across the corner with the signature.
- 7. (i) The Identity Card issued by the Competent Railway Authority of the voters in **original** to be produced for their identification as voter.
- (ii) In case of not having the Identity Card issued by the Competent Railway Authority the Mobile App called 'RESS (Railway Employee Self Service)', where the details of the voter including their PF No. are given, shall be considered.
- (iii) The 'UMID (Unique Medical Identification)' issued by the Railway Authority shall also be considered the identity of the voter.
- 8. Use of Mobile Phone is strictly prohibited in the Polling Booth.

- 9. Polling Agent / Counting Agent should be voter of the same constituency.
- 10. The time of Polling will be from 09:00 A.M. to 04:00 P.M. Time may be extended if there is a queue at the Polling Station at the 04:00 P.M. Concerned Election Officer / Addl. Election Officer shall issue Voter Slip to accommodate the last persons of the queue to cast his / her vote.

The 'Advisory' is issued in consultation with the respected Returning Officer, who has been appointed by the Co-operative Election Authority/ Ministry of Co-operation / Govt. of India.

All the Members of the Bank and other concerned persons are requested to follow the Bank's website on regular basis. The Competent Authority of the Bank will publish further notification related to the Delegate Election-2024 as and when required.
