For example, Yellow or Pink colored Nomination Form will not be accepted for General category.
 - 2. Nomination Form shall be supplied, on request, by the Returning Officer or any other officer authorize by him in this behalf, to any delegate member of The E.R.E.C. Bank Ltd., free of cost.
 - 3. Every Nomination Form shall be signed by two delegate members whose names are included in the list of the delegate members and one of the delegate members shall sign the Form as Proposer and the other as Seconder for the nomination.
 - 4. Nomination Form may be presented in person by the candidate himself or by his authorised person whose name is in the delegate member list, to the Returning Officer or any other officer authorised by him on the date, time and place/venue specified for submission as per programme.
 - 5. Withdrawal of Nomination may be done by any candidate by notice in writing signed by him and delivered in person or by the person duly authorized by him within the date and time specified in the election

- 8. No Delegate who has been a member of the Bank for less than twelve months immediately preceding the date of such Election.
- 9. No Delegate members of the Bank shall be eligible for being a members of the Board of the Bank if such members acquires disqualification as stated under Section 43 of the M.S.C.S. Act, 2002 read with 19J of the M.S.C.S. Rules, 2002.
